NON-LIABILITY OF HOTELS

- The Hotel will not be held responsible for failure to execute obligations specified herein directly or indirectly occasioned by or through or in consequence of war, change of statutes of the Indonesian Government, strikes, riots and acts of God or conditions beyond the control of the Hotel.
- The Hotel reserves the right to refuse, stop or cancel any function which may damage the Hotel's reputation or may affect its business and security.
- The organizer/company acknowledges that they shall be responsible for all property, goods, articles or things (whether belonging to the organizer/company, his servants or agents or any contractor or the invited guests) placed, deposited, brought into or left in the function room, and that the Hotel shall not be responsible for the safe-keeping or custody thereof.
- The hotel will not be responsible for damage or loss of property brought into the hotel. The hotel shall have the right to refuse permission to use its safe without any liability or reason whatsoever.

PROHIBITION
